Cost \$100 ( or 2 bingos, or 1 bingo and \$50.00 )

Can belong to team **includes** benefits ( Jackets, outfits )  
Buy CPDC merchandise at cost  
Get 'member pricing' on workshop and events

Receive bday card (no other gifts)  
2 for 1 for all dances.

### LEVEL 3 - Social Membership

\$50.00 for the year (or 1 bingo) no half year available

Can belong to team but **no benefits** ( ie, Jackets, event fees, etc )  
Buy CPDC merchandise at cost  
Get 'member pricing' on workshop and events  
Discounts at participating merchants  
Receive notification of special occasions  
Receive bday card (no other gifts)  
2 for 1 for all dances.

## **Operating Guidelines Country Pride Dance Club competition Team**

*The competition team will be supported by the Country Pride Dance Club with the condition that there are 8 active members that wish to participate and follow guidelines set by the club. Deadline date of April 30 2017. Will be reviewed at the end of June 2017*

*Team guidelines to be set by the executive board of Country Pride Dance Club based on recommendation from the board and its members. These guidelines will be an active document subject to regular review by the board.*

### **Purpose of the Team**

Is to support the overall vision and mission of the club. To give people the opportunity learn more about dance, and to compete at dance festivals. Demonstrations are also a possibility, and will be co-ordinated with the choreographer, coach, and the promotions director.

### **Who can be part of the team**

Any member in good standing can be a member of the team. Participation in the competition team is subject to the decision of the Chorographer and coach and their decisions are final. There are no age restrictions. Attendance, ability, and attitude will have a bearing on the decision of the chorographer.

### **Viability of the team**

The competition team needs to maintain 8 dancers ( 4 couple ) minimum for the continued variability of the team. If there are less then 4 people ( 2 couples ) the team will be defunct.

### **Practices**

The team will hold practices Sundays at 5:30pm to 6:30pm at Festival Hall. Addition times may be added as needed. Chorography and material taught will be the decision of the Chorographer, and the coach. This will be based on the ultimate goals of the competition team. This includes dances taught, music selection, etc. Suggestions can be made to the chorographer by the members.

### **Costs**

Dance team members will have costs covered by the club based on their membership level. These may include practice space, teaching, outfits, jackets, and event costs.

### **Team Benefits and Commitment**

Dependant on the level of membership of the team member will determine costs covered by the club.

Disputes should be taken to the chorographer and coach first. If the decision is not satisfactory, a written request can be submitted to the board. All decisions by the board are final.
